1. Road Paving:

1-b. Remodeling Bid for Police Chief's Office

MINAUDO MOVED, seconded by Noecker to proceed with the office remodeling project for the Police Chief at a cost of \$2,652.00.

DISCUSSION:

The Chief's office would be moved closer to the main office, Police Secretary and the general public. Three (3) bids were received for the remodeling with the lowest bid being \$2,652.00. The money would come out of the Police Budget. It had been felt there would be more security with the Chief's office being closer to the main flow of traffic. The cost will not be more than \$2,652.00. It was asked if the money could come out of the general fund.

1-c. Ambulance Service Contract

The President and Vice President of Twin Township Ambulance Service, New Lothrop, Michigan, gave a presentation regarding their ambulance services. Some facts provided were:

- 1. Everyone is treated like family.
- 2. Twin Township is a non-profit organization (501C3) based in New Lothrop, Michigan
- 3. There is prompt 24/7 services
- 4. The ambulance service started July 4, 1978
- 5. A seven (7) member board of directors runs the company
- 6. The employees consist of: a business manager, assistant, scheduler, eleven (11) paramedics; eleven (11) emergency medical technicians (emts); and one (1) medical first responder (mfr)
- 7. All other attendants are volunteers
- 8. Twin Township Ambulance services all of Hazelton, Maple Grove, and soon all of Montrose Township; portions of Albee, Flushing, New Haven and Venice Townships are also serviced by Twin Township
- 9. There are two (2) EMT, two (2) MFR, and twelve (12) CPR instructors.
- 10. Billing is done from the home base in New Lothrop
- 11. The equipment is in top condition with ALS
- 12. Currently special tax assessments are received from Hazelton, New Haven, and Venice Townships; there will be no charge for Flushing Township residents if the township went with Twin Township Ambulance Service
- 13. One VSL ambulance would be dedicated to the residents of Flushing Township
- 14. There are monthly public board meetings.

It was determined to postpone the issue until the Township Attorney reviewed the issue with both Genesee County and the local statutes.

1-d. <u>Misty Morning Drive – Drainage</u>

PURKEY MOVED, seconded by Matzke to postpone the Misty Morning Drive issue until Attorney Moulton has researched the issue further.

DISCUSSION:

There are three (3) properties involved: 1) recently acquired by the present owner which is the problem because an excavator dug the low area (creek) leaving rocks on the back of the property; the sprinkling system was also damaged by cuts in the line. The project was never completed due to the weather. There was also a conflict as to what to do with a fence that was moved on the back of the property. There was never a written contract with the excavator. It was recommended by the property owner's attorney, to Attorney Moulton (Flushing Township Attorney) to let the township take care of the issue. 2) one of the three (3) properties involved is bank owned.

Flushing Township received bids for the repair of the low area (creek) ranging from \$5,000.00 to \$14,000.00. It was recommended to offer the homeowner the undertaking of the project and the township pay the resident the money. The property owner would then waive any further action on the issue.

Attorney Moulton will contact the property owner's attorney to see how to resolve the issue since there is a good working relationship between the property owner and the township. The amount offered the property owner would be kept under \$5,000.00. If the property owner would like to fix the damage, he would be reimbursed by Flushing Township or the township could contract with someone to get the issue resolved. Per the Township Attorney, it was not the responsibility of the township to get involved.

DISCUSSION:

All budgets can be amended throughout the year; the proposed budget is amending issues that need to be cleaned up. The Comcast Cablevision, Cell Tower Rental, and the Park Home funds will be put into the General Fund. Out of the General Fund, \$195,000.00 will be put into Road Maintenance, \$4,000.00 into Ditching Maintenance, and \$30,000.00 into the Park Fund. The General Fund will transfer the funds into the Park every year to run the Park.

If at anytime the Park needs more than the \$30,000.00 allocated, the funds will be transferred out of the General Fund (similar to the Building Department).

1-g. Genesee Regional Chamber of Commerce 2010 Summer Youth Initiative Grant

MORFORD MOVED, seconded by Purkey to approve the 2010 Summer Youth Initiative Proposal submitted to the Genesee Regional Chamber of Commerce in support of the Flushing Township's Nature Park "Bringing a Community Together" Program with the following requirements: The award amount of \$18,214.38 is for three (3) line items in the proposed budget: (1) \$1,294.38 for other employment costs consisting of FICA and Workman's Comp for the ten (10) teen staff; \$3,600 for two (2) teen supervisors; and \$13,320 for eight (8) teen staff four (4) students ages 14 to 15 and four (4) students ages 16 to 18. The attached Proposal will be reviewed for other requirements. The program is for nine (9) weeks starting June 21, 2010 through August 27, 2010. Heather Griffin will be the supervisor in charge of the program.

DISCUSSION:

It was recommended to change, if possible, some of the names/dates in the original proposal due to changes in the Board of Trustees.

DISCUSSION:

Since other committees do not take minutes, why does the Parks and Recreation Committee need to take minutes? The issue will be discussed in the future as to having someone on the Parks and Recreation Committee taking the minutes. The Parks and Recreation Committee will be run like a Committee.

Per the township attorney, the Parks and Recreation is not a Commission, but a sub section of the Board of Trustees. The only Committee that needs formal minutes taken is the Board of Trustees, Planning Commission, and the Zoning Board of Appeals.

PURKEY MOVED, seconded by Minaudo to postpone the issue until the Committee and Supervisor decided how to handle the issue.

DISCUSSION:

Will the current clerk take the minutes at the next Parks and Recreation Committee Meeting? Since the Park receives grants, would the minutes be required for that purpose? The Park doesn't have the legal status to receive grants.

The Township Attorney stated there wasn't anything in the Policies and Procedures Manual regarding the Parks and Recreation Committee other than three (3) lines indicating who would be on the Committee. It was recommended to get proposed language in line and then decide if there should be a recording secretary for the Parks and Recreation Committee.

 - "The board should know that it is a rare situation that an agency submitting a proposal for the first time gets full funding. Heather put together a well written proposal that gave the reviewers great confidence for moving ahead."
- 6. **PECK** felt it was wonderful to get the \$18,000.00 and the proposal was very well written; hopefully we can be responsible as to how the money is spent at the Park; **PAVING:**

<u>Deland Road</u> will be paved between Coldwater Road and Stanley Road; <u>Johnson Road</u> will be paved between Stanley Road and Mt. Morris Road; <u>Morrish Road</u> residents are "tickled pink".

The Police Department Budget is being worked on, no definitive answers are available at present. Every Community is facing the same problems; we have to live within the budgets.

7. **PECK** stated he was very sorry to see Mr. Eric Swanson resign from the Planning Commission after a long time with great experience. The Planning Commission represents a wide range of walks of life; good sound decisions have to be made on each and every case that comes before the Planning Commission.
