#### 2. Update on PA System in Board Room

The Supervisor has checked with Comcast Representative Mr. Gerald Smith (Mr. Smith), who is in charge of the Public Education Grant (PEG) Funds, regarding covering the cost of the PA System for the Auditorium. Mr. Smith stated the cost was allowable, but Attorney Steve Moulton (Attorney Moulton) will review the Comcast Contract regarding any restrictions for the PEG Funds.

Three (3) companies have given their suggestions as to what Flushing Township needs in regards to the PA System. Specifications will be put together for the project and once the specifications are on paper, the Supervisor will email the three (3) companies for their final sealed bids. A Board decision will be made at the next meeting.

#### **NEW BUSINESS:**

#### 1-a. <u>Explanation of Public Education Grant (PEG) Funds Regarding its Balance,</u> <u>Restrictions, and Uses</u>

Public Education Grant (PEG) Funds come from Comcast Franchise Fees. The fund can only be used for capital costs/improvements related to broadcasting. The following items are acceptable from the PEG fund and would not come out of the Township's General Fund:

- a. Updated PA System in the Auditorium
- b. Videotaping of Board Meetings
- c. Replacement of floor and ceiling tiles in the Auditorium with new and updated material
- d. New and updated creation of the Charter Township of Flushing Web site

Mr. Smith has informed the Supervisor that all of the items listed above are allowable under the PEG but due to the restrictions, Attorney Moulton will be reviewing the matter. Currently, the Flushing Township PEG Fund Account has \$27,715.50; the payments are received quarterly from Comcast.
