- 5. **GAGE:** met the Smith family this past summer at Church; when the tradegy happened, Gage went to Mrs. Smith because Gage also lost a son suddenly with a heart problem. Great knowing Mrs. Smith.
- 6. **BIRCHMEIER:** very emotional issue but thanked Mrs. Smith for coming to the meeting.
