Supervisor Thorsby gave an explanation for the need of a Special Assessment for the Coldwater Road Extension, and the Township's role in collecting funds, holding funds and paying bills for repairs and maintenance authorized by property owners.

-Mr. Fred Meredith commented emphasizing the Township does not authorize any work on the road, they simply collect funds and pay the bills accordingly. Any work is determined solely by the property owners on the Coldwater Road Extension.

Attorney Steve Moulton explained the approval process for a special assessment. Resolution 21-12 indicates that proper steps were taken, signatures obtained on a petition of the 15 separate parcel owners. With approval, the Township Board has authorized the amount of \$300 to be placed on tax bills for these 15 parcels in which the Township will collect, hold and disperse the money as directed by the property owners. The Special Assessment will identify exactly which properties are included by property owner name, address and parcel number, and will last for a period of 5 years.
