PUBLIC HEARING OPENED AT 7:14 PM.

Mr. Fred Meredith, a resident of Coldwater Road Extension, gave comment on the need for a special assessment for the repair and maintenance of the Coldwater Road Extension. He gave explanation as to the township's sole role of collecting funds, holding funds and then paying the bills. Mr. Meredith gave further clarification as to the duration of the assessment, which will be for a 5-year period instead of a 10-year period; the cost will also increase from \$200 to \$300 for each of the fifteen homeowners. Mr. Meredith has already circulated a petition and obtained 14 of the 15 signatures needed in in order to move forward with this special assessment.
