V. NEW BUSINESS:

1. Discussion pertaining to storm related property damages – Supervisor Thorsby

Supervisor Thorsby discussed the microburst that affected Flushing Township. There were at least 44 homes damaged. Consumers Energy and the Genesee County Road Commission worked several days to restore power and road access to the affected areas. The Township does not have funds allocated nor the man power to handle the help needed by residents. After evaluating the properties and consulting with Supervisor Thorsby, Genesee County Emergency Management and FEMA found that the damage did not qualify for any funding. Supervisor Thorsby contacted several tree services to gather information on the possible wood chipping and clean up in the affected areas. The tree services gave prices ranging from \$400 to \$1000 per hour. There is a rough estimated time of approximately 30 to 40 hours to complete clean up. He also stated that Emterra would also make dumpsters and trucks available if needed to hall chipped debris away. Supervisor Thorsby suggested that a motion be made to amend the budget, authorize the funds to be allocated for the clean up of the debris left beside the roads.

TRUSTEE BAIN MOVED, supported by Trustee Westenbarger to make that motion and contract with a tree service to clean up the affected areas.

After a lengthy discussion regarding the homeowner's responsibility and any assistance the Township would be able to offer to help residents, the following motion was made.

TRUSTEE BAIN MOVED, supported by Trustee Westenbarger to amend previous motion to include a price not to exceed \$30,000.
