Supervisor Thorsby reported that under the American Rescue Plan Act, the Charter Township of Flushing will be receiving \$1.01 million Federal Stimulus Funds. The distribution of these funds will be in two installments, half being sent this year and the other half in 2022. Use of the funds are limited to very specific items including, but not limited to response to COVID-19 emergency and its negative economic impacts and investments in water, sewer and broadband infrastructure. The funds are to be used by 2024. After lengthy discussion, Supervisor Thorsby suggested holding a Public Hearing to allow residents to share their input as to how these funds could be best put to use for the benefit of the township.

5. Discuss railroad easement and contract on Turner Road.

Attorney Steve Moulton gave a brief synopsis of the agreement adopted in 1986 between the Grand Trunk Western Railroad Company and the Charter Township of Flushing from inception to current day. After discussion, the following motion was made.
